Background

Established in 2014 and formally launched in 2015, Galway City Community Network (GCCN) is the Public Participation Network in Galway City. The GCCN work is motivated and guided by values of:

- Sustainability and a concern for preserving and protecting the natural environment.
- Equality and a concern for non-discrimination, valuing and respecting diversity, empowering people, and securing access to social and economic resources.
- Culture and a concern for empowering, and fostering the diversity of cultures in the city and enabling people to express their creativity.
- Community and a concern for the physical space, identity, and/or interests shared by a group, where people enjoy wellbeing and harmony, organise collectively, and engage in shared creativity.
- Empowerment and a concern for representation and participation in decisionmaking and democracy in the city.
- Inclusion and a concern for fostering and ensuring a sense of belonging to and opportunities to engage with one's community and the city.

VISION

The GCCN vision for Galway City is:

Galway, a creative and inclusive city that respects and values its people and communities, their wellbeing and quality of life, that will develop a vibrant, sustainable, economy and environment and participative and transparent governance

AIM

The aim of Galway City Community Network is to co-ordinate and support the representation of the community, voluntary and environmental sectors in Galway City.

The twin objectives that GCCN pursues are to

- Submissions on the Sustainable Development Goals National Implementation Plan.
- Submission on the draft Ireland 2040 strategy.
- Submission on the review of Local Community Development Committees









THE GCCN SUBMISSIONS WERE UNDERPINNED BY PARTICIPATORY PROCESS. EXAMPLES INCLUDE:

- GCCN initiated a process to inform members of the busking and street performance community that Galway City Council were discussing Byelaws that would have a direct impact on their work. We leafleted (thanks Eleanor Hough) buskers for a number of weeks and then hosted a meeting for them to discuss the draft Byelaws.
- GCCN organised a preparatory workshop for members to support them to contribute to the workshop on Local Economic and Community Plan planning;
- GCCN organised a special meeting to discuss the submission to the Ardaun Local Area Plan;
-and another to discuss the GCCN submission to Ireland 2040

- Healthy Ireland GCCN worked closely with Galway City Council and the HSE locally to develop the Galway Healthy City initiative - GCCN supported the LCDC's successful application to the Healthy Ireland fund that secured €100,000 projects agreed by LCDC until April 2018. GCCN led the process to develop the strategy and application. GCCN is on the Steering Committee for Galway Healthy City.
- GCCN is active in the Social Inclusion Subgroup of the LCDC and is represented on the LECP Advisory Group.
- GCCN co-organises the Flowers for Magdalenes event in Galway City annually.
- GCCN collaborated with Galway City Partnership to organise training for GCCN members and others from the Charities Regulator and on data protection
- National participation GCCN continued to participate at a national level with the Network of PPN Resource Workers.
- Galway2020 GCCN continued to engage with G2020;

COMMUNICATION



By the end of 2017, GCCN use of social media had increased significantly. Our Facebook followers have grown 1/3 in 2017 to over 600. Our Tweets now regularly reach over 500 people & up to 2,500 people... adding up to 35,600 in last 3 months of the year alone.
