#### 1. Corporate Plan Update

### 2. Public Realm Strategy

Ms M Beirne gave a presentation on Galway City Councils Public Realm Strategy. Two no. hard copy draft strategies were also circulated for perusal and the strategy was met with the approval of the members.

#### 3. Short Term Letting – Legislation, implementation & associated issues

Ms E Silke gave a presentation on the new Short Term Letting Regulations introduced in July 2019. Members were in agreement that more resources and staff were vital in enforcing the regulations. Concerns were raised regarding the practical implementation of the legislation including student/tourist accommodation, apartments above pubs/commercial properties, illegal dumping, homelessness and commercial rates being applicable to short term lets. Members called for the matter to remain on the agenda going forward.
