Community Support Forum

- 180 support units in the city
- Collaboration by the local authority, SICAP, Community Forum, GCP, GCCN
- A budget fund for community support of €65,000 is made available
- 15 Applications have been approved to €30,000
- Funds Available by DCRD and Social Enterprise Ireland
- There is an issue in opening certain community facilities in phase 3, 4, 5.

North West Regional Assembly - NWRA

- David Minton held meeting with Neil, Donal, Declan
- Economic Report on Covid19 risk to business - Regional Economic Analyses
- Looking at REDF Regional Enterprise Development Fund for 2021-2027
- Note that the region is in Transition
- The rate determined is on the exposure of industry and the rate is compared to the national average.
- Currently working to look at creating a stimulus programme for the north west region over the next 6 to 8 months from the national government.

Local Enterprise Office Galway

- Applications for Covid19 enterprise support are high
- Shortage in annual budget due to over application of funds, the enterprise is now requesting a second round of funds to be made available.
- There are 13,000 business continuity vouchers applied for nationally
- 2/3rds of applications are approved, the remaining 1/3rd are advised to another LEO support
- OTV-Online Trading Voucher, 64 applications since March with the normal annual applications at 70
- 10% required for grants
- 2nd application allowed for OTV
- Applications have tripled overall
- 8 applications approved for micro finance
- 50,000 loan available
- restart grant, rates rebate for SMEs
- Social Enterprise have continuity support.
- 2/3 rd of business got support on information for continuity voucher the 1/3 got alternative support
- A national social Enterprise Fund is available

Chamber of Commerce

- Restart Grant
- Covid19 Payments need to be supported but reviewed in relation to part time workers
- Continuity Voucher Launched
- Acknowledge and implement the public realm strategy

- Adopt interim guidelines by local authority to respond to covid 19
- Adopt a programme to implement a economic stimulus

#### Galway City Market
