

#### **GALWAY CITY COMMUNITY NETWORK**

## **MEMBERSHIP & REPRESENTATION**

Membership of GCCN is drawn from the community, voluntary and environmental sectors in Galway city.

GCCN representatives are elected from the membership organisations and represent GCCN on a range of structures including:

- Local Community Development Committee (LCDC)
- Strategic Policy Committees (SPC)
- Galway Joint Policing Committee (JPC)
- Galway City & County Childcare Committee
- Regional Drugs & Alcoholic Task Force
- Galway City Partnership

The Secretariat is elected annually by the membership and co-ordinates the work of GCCN between Plenary meetings.

### **LINKAGE GROUPS**

Linkage Groups are subgroups of GCCN that meet on a thematic basis to discuss and develop GCCN policy in the relevant area.

They support the GCCN representatives and provide the platform for electing replacement representatives as appropriate.

The Linkage Groups are open to members of all GCCN affiliated groups/organisations and others that have a commitment to the issues being discussed.

#### **PILLARS**

There are three Pillars (categories) in GCCN and each member must opt for membership of one.

- Social Inclusion for organisations whose primary objectives and activities focus on social inclusion/social justice/equality;
- Environment for organisations whose primary objectives and activities must be environmental protection and/or environmental sustainability;
- Voluntary for organisations whose primary objectives are other than those listed above.

#### **HOW OFTEN DO MEMBERS MEET**

- GCCN members meet in Plenary four times a year - one of these meetings is the Annual General Meeting.
- The Secretariat meets on a monthly basis;
- The Linkage Groups meet on a regular basis;
- There are regular thematic meetings to which members of GCCN affiliated organisations and groups are welcome;

GCCN seeks to organise innovative events on a regular basis to which members of affiliated groups/organisations are welcome.
