Príomhphointí pléite / Key Issues Discussed:

The minutes from the last meeting dated 11th March 2022 were proposed by Cllr. D. Mc Donnell and seconded by Cllr. E Hoare.

Matters Arising

Homeless Report & Update / Housing First

- Minimum standard inspections on PEA not currently being carried out by GCC. Concerns can be raised to Housing Department through Galway City website, then referred to COPE for follow up.
- Alternatives for Glen Oaks GCC currently advertising and seeking tenders for Cold Weather Response for winter 2022 / 2023. Tenders due June 2022.
- Modular Homes –There is no time limit on services offered, HAP will also be sourced where possible through Homeless HAP Team. Some allocations through CBL.
- PEA Concerns in Galway City were acknowledged:
 - 15 units under student accommodation
 - NTQ's are becoming a day to day concern.

- Westside modular housing is full
- Corrib Haven is full.
- Traveller task force trying to seek solutions.
- Housing First GCCN welcomed advocacy on behalf of Galway City Council
 to increases targets. Request for update on 1-bed units from Department –
 motion has been adopted but no reply from Department to date.
- GCCN advocated that we do not return to dorm style accommodation for Cold Weather Response.

Youth Homeless Strategy

Karen Feeney from Galway Simon provided an update on the Youth Homeless Strategy. She outlined the importance of a multi-disciplinary approach and noted that since the inception of the Youth Service, they have engaged with a number of young people. They have provided intensive interventions and have helped a number of young people secure long term housing. The various levels of supports were also outlined to include Psychology Service, Occupational Therapy, and Health Supports to name but a few.

- Youth service worked with 35 young people under the age of 25 in 2021.
- Concerns were raised regarding the shortage of accommodation available. An increase in hidden -homeless was outlined along with students being required to couch surf. It was queried if there was any data to back up the note of couch surfing, noting that this has a negative knock-on effect on these individuals.

Anti-Social Behaviour Strategy

Dermot Mahon provided an update on the ASB Strategy, noting that changes hand been outlined in red. It was noted that to progress a case for eviction through he courts the Local Authority is required to provide a significant level of evidence to back up their claims so it can be difficult.

Main concerns raised regarding:

- ASB not being delt with appropriately.
- Caravans are parked illegally on schemes and not being removed.
- Unauthorised occupiers wee also noted as a concern along with instances of domestic violence.
- Voids within the city becoming targets for ASB.
- Tenants with a history of ASB being transferred from one scheme to another.
- Need to another Tenant Liaison Officer
- Is there collaboration with Gardaí?
- Dangerous, unleased dogs
- Illegal dumping
- Criminal investigations

Responses:

- The definition of ASB is very tight and so makes it difficult to obtain evidence under this. Sometimes the Local Authority will pursue possession orders for rent arrears where possible rather than anti-social behaviour as it is easier to evidence.
- Since 2014, the legislative power for Local Authorities changed with the introduction of the" right to appeal", which has made it extremely difficult for Local Authorities to pursue possession orders. Since then, zero possession orders have been received from the courts.
- Caravans it was noted that illegally parked caravans are not specifically a housing issues, however the Local Authority do follow up with this. It is deemed to be a breach of tenancy rather than anti-social behaviour.
- Unauthorised Occupiers This also falls under Breach of Tenancy and tenants are made aware. If anti-social behaviour occurs as a result, it then proceeds through the courts.
- Domestic Violence processes are in place whereby barring orders and exclusion orders can be obtained through the courts.
- Voids CCTV are installed in voids to prevent ASB and protect the void.
- Senior Housing Estate Liaison Officer Position was filled, but person left.
 Recruiting again.
- Transfers due to ASB ASB is not grounds for a transfer. Transfer will be considered on advice from Gardaí or if there a threat to life. Often when transferred ASB issues do not follow.
- Gardaí regular meetings between Gardaí and Local Authority.
- Dogs Tenancy agreement and tenant's handbook list breeds of dogs not permitted. The Dog Warden follows up where necessary. If persistent noncompliance then it is a breach of tenancy which will be dealt with through the formal process.
- Illegal dumping Currently dealt with by Environment Department as it is a breach of the bye-laws. Housing Department to highlight this in the Strategy as tenant responsibility.
- Criminal activity at a property will be dealt with by Gardaí and they will
 prosecute individuals. Local Authority will not automatically evict a tenant
 from property due to criminal activity involvement, a process has to be
 completed to secure possession of the property and may need to go to Court
 to evict.

Strategic Plan for People with a Disability - Q1 2022 update

Dermot Mahon provided an update on this and noted that the steering group have been meeting on a quarterly basis to discuss. It was also noted that the department had requested updates on this at each SPC meeting. The staff were complimented for this report and progress to date.

- Capital Funding Department announced in April 2022 that property acquisitions may re-commence.
- Old Ballybane Road 6 disability units to be provided within scheme of 58 units planned.

- Cost of construction was raised as an issue. Department have introduced a mechanism to share the burden of construction costs due to rising inflation. C It is intended that they may fund up to 70% of the increases costs. Currently working on schemes with fixed price contracts. Schemes that are going to tender will be sent to the Department for approval. It was noted that there is much difficulty trying to get contractors to commit to the costs. Department are fully aware of the issues.
- Merlin at procurement stage and due to go to tender.
- Ballybane site negotiations still ongoing. Progressing very slowly.

AOB

- Update provided on challenges facing Ukranian Refugees:
 - It was noted approx. 150 people in Glenoaks, 120 Corrib Village, 50 in Westwood student accommodation and 18 in a B&B in Salthill. This accommodation was not arranged by GCC.
 - Acknowledgement and thanks given to Galway Simon, COPE Galway and volunteer centre for their work to date.
 - Students returning Ukranian families to be relocated from Corrib Village and Westwood.
 - Pledged accommodation was being inspected
- Kiltullagh House planning permission granted and appealed to An Bord Pleanala. Awaiting outcome. Insurance claim submitted including rebuild costs.
- Advances Purchase scheme 1 expression of interest received.

Short Term Lets – concerns raised on low availability in Galway City, request update on any changes to rules on short term lets, given the current housing crisis situation

Príomhphointí pléite / Key Issues Discussed:

Meeting started at 8:30am.

1. Minutes and matters arising

The minutes were adopted.

Cllr Imelda Byrne raised the matter of Short-Term Lettings and the shortage of staff to address the problem. Patricia Philbin, Director of Services, responded that the Council had received approval to recruit 3 additional staff as part of the Office of eth Planning regulator Revie. No additional staff have been recruited to dela with the Short-Term Lettings and Vacant sites as yet.

2. Discussion on Joint SPC Meeting

- B. Mulligan observed that it was a good idea to have a joint meeting. Those present had been given a dose of reality by the representatives of the Northern & Western Regional Assembly and Irish Water.
- D. Hambleton expressed the view that the city is going to stand still until the lack of wastewater capacity issue has been sorted out. It has been known since 2006 that additional capacity will be necessary and until that is provided development will be constrained. Political support from TDs will be necessary to address this.

Peter Keane's view was that it was a good idea to have the joint meeting and welcomed the information provided by the NWRA which was very relevant. He was very disappointed in the content of the Irish Water presentation and particularly disappointed with the proposed upgrade at Merlin which will not be in place until 2023/2024. He invited comments from the others present – no Councillor or member of the Executive made a comment.

Peter Keane suggested that another joint meeting would be held and 10:00am on the 13th September was provisionally suggested.

3. Update on the 3 Castles project

Jim Higgins, Heritage Officer and Ann Marie Cusack, Executive Architect, attended with Fergal McNamara, 7L Architects. Fergal McNamara, who led the multi-disciplinary team that worked with the contractor on the project gave an update on the project.

Phase 1 works on Menlo Castle, which involved removal of ivy, have been completed with minimal damage to the building. The temporary fence around the castle will remain in place until it is at a stage equivalent to that of Merlin and Tirellan castles now.

Phase 2 is currently underway which involves works to the remains of the tower house, the oldest part, and part of the spine wall. Bat surveys will be undertaken in the next few weeks.

Phase 3, the next most important, is subject to tender, funding and contract. Phases 4 and 5 are subject to funding. Funding is capped at €85,000.

4. Public Realm Feasibility study on Tirellan and Merlin

Fergal McNamara presented a case study on Carlingford Castle in Co. Louth. This was an OPW project funded by Fáilte Ireland. Works had been ongoing on it for 10 years before he became involved. It is a royal castle in an Anglo-Norman village. The construction of a former rail line resulted in the removal of part of the castle. The intention was to enable it to be opened to the public and it also involved landscaping works. It hasn't been possible to achieve full universal access.

Tirellan Castle is a 17th century replacement of an earlier castle. As it is today, it is only half of its original length – it lost a gable in 1984. It is located just outside the Public Realm study area. There isn't a brief for the next stage yet. There is an opportunity to create a special place beside the castle.

Fergal McNamara commented that, to its credit, the nearby housing scheme had taken Merlin Castle as its focus. There is an opportunity to create a garden and retain the best of the trees within the bawn. It would be possible to achieve access to the two lower rooms but it will be more difficult to achieve access to the higher level.

Discussion

- B. Mulligan enquired if it would be feasible and desirable to roof Merlin Castle. Fergal McNamara expressed the view that a strong rationale would be needed to justify the investment and it would be necessary to speak to the Department as soon as possible. In his opinion, there is value in the castle without a roof. Access would always be restricted would the additional investment be justified?
- D. Hambleton expressed the view that there is a tremendous opportunity for the public in the lands around Menlo Castle but there isn't a plan to realise it.

Cllr Frank Fahy welcomed the presentation. He had initiated the project. Funding had been put by every year since 2015. He would like to see Merlin Castle roofed at some stage. As his family has been in Menlo since the 1640s, Menlo Castle is his preferred castle. The sum of €130,000 was set aside last year which has leveraged other funding.

Cllr Peter Keane congratulated Cllr Fahy and others for putting money aside and thanked the Executive for their work. He asked when are going to bring them to the level of Carlingford Castle? Jim Higgins concurred and asked why stop here? At Tirellan Castle only half the ground plan is evident. In 2014 consideration was given to raising the walls to create an enclosure for events. A dugout canoe had been found in the river near the castle. It would be possible to roof Merlin Castle he said. Many castles, in both private and public ownership, have been roofed. Having removed the ivy, it is evident that Menlo Castel is in worse condition than first thought. He agreed with Derrick Hambleton about the opportunity presented by the surrounding lands, bawn, walls and towers, etc. The other two castles have been consolidated into a safe condition but Menlo Castle needs more work.

Jim Higgins agreed that it is necessary to identify a use for Merlin Castle. Great work is being done by the Friends of Merlin Woods. It would be a shame not to roof the castle. He would prefer to see the window on the ground floor restored with the entrance at first floor level.

Cllr P. Keane was of the opinion that the presentation should be given to the full Council, perhaps at the September meeting, with a view to seeking support to bring the restoration of the castles to a further stage.

5. City Development Plan Briefing

Caroline Phelan, Senior Planner, gave an update on the schedule which had commenced in January 2021. The Chief Executive's Report following the public consultation stage on the Draft Development Plan will be issued to Councillors this week and will be made available online next week. Councillors will then have the opportunity to propose amendments to the draft plan.

B. Mulligan enquired if the Planning SPC would be afforded the opportunity to consider the Chief Executive's Report and observed that the Planning SPC had not been afforded an opportunity to engage in the development plan making process to date. Cllr Peter Keane observed that there will be little time for a Planning SPC meeting between now and the end of July as several Council meetings are scheduled at which the Chief Executive's Report will be considered.

Cllrs Larkin and Crowe and the Senior Planner referred to the process laid down in the legislation. B. Mulligan observed that the role of the Planning SPC, also under legislation, is intended to be the formulation, development, monitoring and review of policy. Cllr Peter Keane undertook to consider holding a Planning SPC meeting in September at which stage the material amendments to the Draft Development Plan could be considered.

6. OPR Report briefing

Patricia Philbin, Director of Services, gave an overview of the Office of the Planning Regulator's Review and said a highly effective rating had been achieved. [In fact, the top rating of 'highly effective' was achieved for its Planning Enforcement function only, while an 'effective' rating was achieved for most other functions. Its 'Own-development' function achieved a 'some improvement needed' rating. The following is taken from the OPR Review Report: "The general finding of this report this that the planning department's performance is effective for the most part."

The report acknowledged that the planning team was small and, because it is an urban local authority, was dealing with more complex developments. It noted that the invalidation rate of applications for planning permission was much lower than the national average.

The report included 19 recommendations to be implemented. Caroline Phelan said these are being implemented on a phased basis given Covid constraints and the priority of the development plan.

Cllr Owen Hanley observed that perhaps there was an opportunity to expand ecological and heritage expertise on staff. There is to be a briefing on proposed resources at the next Council meeting.

7. Development Contribution Levies and Vacant Sites updates

Emma Silke, Administrative Officer, responded to Cllr Owen Hanley that the new Development Contribution Scheme had seen contributions increase from €2.036m to €3.2m. In relation to the 6 Vacant Sites, one owner has paid the levy due, a determination is awaited in relation to another vacant site and a reminder has been sent to the other 4 vacant site owners.

8. Agenda for the next meeting

Draft Development Plan update following consideration by Councillors of the Chief Executive's Report.

Cllr Crowe requested that on-street Utility Boxes (ESB) be on the agenda. He observed that some are designed like "bar counters". He enquired do they go through the planning process. If they are below a certain volume they may be 'exempted development'. Liam Blake, Senior Executive Planner, will report to the next meeting.

The Work Programme for 2023 – B. Mulligan believes it will be too late then to consider the draft Work Programme for 2022.

9. Any other Business

D. Hambleton reminded the meeting that new guidance for the ioninuation of Heritage Plans was due to be issued this month and that it had been stated at a previous meeting [10th December 2021] that "Whether or not that guidance issues, it is proposed to go ahead with seeking expressions of interest in joining the Forum." The Senior Planner reported that after the last Heritage Officers' meeting the Officers had decided to set up a sub-group to determine the appropriate methodology. She said she could get Jim Higgins to let D. Hambleton know what is happening.

It was agreed to put the Heritage Forum on the Agenda for the September Planning SPC meeting. The meeting closed at 9:50am.

Peter Keane chaired the meeting. He observed that this joint City and County Planning SPC meeting was taking place in the context where no amalgamation of Galway City and County Councils is to happen at this time or is likely to happen at any time in the future.

Presentation by Representatives from the Northern & Western Regional Assembly (NWRA)

David Minton, Director, John Daly, Economic & Sustainable Development Officer and Frank Flanagan, Chartered Engineer, Senior Executive Planner, attended in person.

David Minton explained that the purpose of the Regional Spatial and Economic Strategy (RSES) is to provide for urban-led regional development and includes the Galway Metropolitan Area Spatial Strategy (MASP). The NWRA advocates on behalf of the Region and leads on Biodiversity and Climate Action. The European Regional Development Fund (€350m) is ending and will be replaced by a new fund (€211m).

The focus at this meeting will be on the Galway MASP. There was no MASP when the original National Planning Framework (NPF) was published – the MASP was introduced in the RSES. MASP is used by most modern OECD countries. David referred to the Bilbao Case Study of metropolitan planning - the NWRA have partnered with Bilbao. The people of Bilbao see themselves as being Basque. They have adopted a bottom-up approach to municipal planning.

It was critical that Letterkenny, Sligo and Athlone were included in the RSES as Regional Growth Centres. Galway city doesn't have the same influence in the NWRA Region as Dublin has in the East Region but it has great potential.

Biodiversity, Innovation and Climate Action are key drivers. The Galway MASP is a key engine for growth.

The population growth target in the RSES for the Galway city is to achieve a minimum growth of 23,000 by 2026 – a population of 103,000. The NPF minimum

target population to be achieved by 2040 in Galway City and Suburbs is 120,000+. Tuam and Ballinasloe are Key Towns.

David said that "now is the time to have a conversation about how we can best make the MASP work."

He referred to a second Case Study – the Cork Area Strategic Plan (CASP) – as another example of a bottom-up approach to municipal planning. It commenced in 1990 and was jointly sponsored by Cork City and County Councils. Cork is thriving! Governance is by a multi-agency committee which meets quarterly.

John Daly, Economist, then spoke about trends in the implementation of the Galway MASP. The target was to deliver 50% of all new homes that are targeted within the MASP. Within the city between 2016 and 2021, progress to date has been above that target.

The target for the Galway MASP is to grow the population by 27,500 by 2026 and a further 14,500 by 2031, relative to the population in 2016. The absolute numbers of new housing completions in the MASP are fairly low ranging from 151 in 2016 to 377 in 2021 – total of 1,640. Based on these numbers and, using an average household size of 2.58, it implies a population growth since 2016 of only 4,226 versus a target MASP population growth of 27,500 by 2026. We are already halfway through the 2016-2026 period. We need to build up the MASP more.

There is an opportunity to use vacant and derelict commercial units in the MASP - 801 in September 2020 and just under 600 vacant and derelict residential units - 82% of these vacant units are in Galway City & Suburbs.

John showed a graph of the difference between disposable income per capita in Galway versus the state average for the period 2000 − 2020. The disposable income per capita in Galway in 2020 was €2,000 lower than the state average in 2020 having been slightly higher that the state average in 2009 and 2010. The gap in disposable income per capita is on an increasing trend.

John announced that a Regional Development Monitor Hub to show if 'Balanced Regional Development' is being achieved, will be launched in Q2 of 2022. It will have 60 socio-economic indicators across 4 themes and will be available to all online.

The 4 themes are:

- 1. Our People and Places
- 2. Our Green and Sustainable Future
- 3. Our Region's Economy and
- 4. Our All-island Perspective

David Minton brought the NWRA's presentation to a conclusion by saying that "we don't want three or four visions for Galway – we want One Vision!"

He then posed the question "Who is going to lead that One Vision?"

Cllr Niall Mc Nelis asked who leads the Cork Area Strategic Plan (CASP) and what funding is there for it?

Derrick Hambleton warned that whoever leads the vision for Galway mustn't leave the community out. He also made the point that there is a lack of awareness of the NWRA.

Cllr Owen Hanley suggested that we need European investment.

Brendan Mulligan observed that there is significant private investment being made in Galway but that there is a lack of public sector investment. An overall vision is missing.

Caroline Phelan noted that the Office of the Planning Regulator (OPR) is adopting the ESRI's projections of population which are incredibly conservative and are totally out of kilter with the NPF's targets. The OPR is asking Galway City Council to reduce the population targets in the Draft Galway City Development Plan. The OPR is refusing to meet with Dublin City Council re population targets and there are also problems with Cork City Council.

Cllr Michael Connolly, Galway County Council, pointed out that Galway city is also dependent on communities in Clare and Mayo. Galway is underfunded – the strategy may be in place but the funding is not. Cork and Limerick are getting the funding but Galway is not. The MASP in Bilbao reinforced the local governance structure rather than undermining it.

David Minton said we need one shared vision that everyone can buy into. Galway city is the only reason that the Northern and Western Region is not categorised as an 'Underdeveloped Region'.

Caroline Phelan referred to a vacuum – no legislative basis for the MASPs and there is a lack of guidance and support.

David Minton mentioned that Kilkenny & Carlow are mobilising, as is Limerick. There is a unique opportunity for Galway City and Council to come together.

John Daly agreed with Derrick Hambleton's observation that there is a lack of awareness of the NWRA.

Cllr M. J. Crowe supported the point that Caroline Phelan made about the OPR's view in relation to population projections and found some of the OPR's submissions to be perplexing.

Michael Owens. Director of Services, Galway County Council noted that the new County Development Plan has just been adopted. He expressed the view that delivering the MASP requires a joint approach. The City & County Councils have engaged with the Department in recent days.

The NWRA's representatives left the meeting at this point.

Presentation by an Irish Water Representative

Page | 14

Niall Tuke, Asset Investment Manager, Irish Water joined the meeting remotely at this point and gave a presentation on the current capital investment plan - 'Revenue Control (RC) 3 Capital Investment Plan 2020-2024'. The Water Services Strategic Plan is the key document. An investment of €5.3bn is proposed for 2020-2024, 58% allocated to wastewater and 42% to water.

The next Regulatory Control (RC) Period will be 2025 - 2029. A significant level of investment will carry over from the current investment plan. Investment will continue to increase up to the 2030s. The needs and interventions to form the priorities for RC 4 are under review. A Stakeholder Engagement Plan is in development.

After the presentation Derrick Hambleton noted that there had been no mention of Galway at all. Going back to 2006-2009, reports had recognised the need for a second wastewater treatment plant on the east side of the city. He enquired if there was any update on this.

Brendan Mulligan referred to the ongoing problem of discharges from Storm Water Overflows during relatively low intensity rainfall events.

Niall Tuke responded that there are a number of projects. The Galway Strategic Drainage Study will look out to 2075. Scoping will commence in 2023 and will be complete in 2024. This will address servicing development in Galway east. It is being referred to as 'Additional Capacity for Galway' rather than the Galway East WWTP. The Mutton Island WWTP has a capacity of 170,000 p.e. while the current loading is approximately 100,000 p.e. The Drainage Study will validate the incoming flows and will also address the SWO's and he acknowledged An Taisce's submission on the Draft Galway City Development Plan.

As regards the Drainage Area Plan, data gathering has been completed and model building is underway. Solutions will come out of that in 2023 which will inform the RC 4 Capital Investment Plan.

The SWO's issue will hopefully be addressed over the coming years, Niall Tuke said.

Brendan Mulligan expressed concern about the lack of urgency in advancing plans to meet the needs of the NPF population targets for Galway and to address the current SWO problem.

Niall Tuke responded that a new WWTP would take 10 years from 2024 to deliver with the best intentions. Work will be prioritised over the coming period once the Drainage Area Plan is complete. These things take time. Irish Water is taking a national view addressing significant strategic issues. It is programming actions in relation to Galway to develop the solutions.

Cllr Peter Keane noted that Galway City Council had adopted the Ardaun LAP 4 years ago to address housing need. He asked is it the case that we can't invite planning applications for Ardaun until the study is completed in 2024 and

thereafter implemented? Will it be years before we can see housing being developed in Ardaun?

Niall Tuke responded that an upgrade to the network is planned. The design of a new "balancing tank" will be completed this year and it is proposed that it will be built in 2024.

Michael Owens, Director of Services said, that from a county perspective, there are recurring themes in restriction of development due to a lack of Wastewater Treatment Plants in settlements in the county. Athenry specifically and other settlements, such as Mountbellew, that couldn't be developed. There are problems in Connemara that are preventing the addressing of population decline.

Niall Tuke responded that Irish Water is awaiting approval from An Bord Pleanála for a wastewater treatment plant for Mountbellew. There is a Small Towns and Villages scheme to address growth problems – approximately 40 towns are involved.

Niall Tuke left the meeting at this point.

Any Other Business

Derrick Hambleton suggested that there be regular joint City and County SPC Meeting every 6/12 months. Cllr Peter Keane thought this was a good idea and suggested that maybe every 3rd SPC meeting could be a joint meeting.

Cllr Owen Hanley asked that the Galway Airport Site be on the agenda for the next meeting.

Pre summer there were 7300 requests for school places, no figures of requests from September yet.

No comprehensive figures from government of exact number of Ukrainian refugees in the city.

106 are in shared accommodation and 36 in vacant properties

Currently 800 a week into the country and expected to reach 50-60k by Xmas

Four support worker posts have been filled in the city; 1 fulltime and 3 part time (all employed by GCP and includes 2 translators).

1.5 \$ GCC and 2 x .5 \$ SICAP

EU funding support is in 6 month cycles that began March 2022.

GVC 2 staff to work with community organisations to promote Ukrainian inclusion.

Elaine raised the concern about no Vacant Housing Officer appointed in the GCC and surely if the position was filled it would be useful for assisting with housing concerns in the city. She brought it to Brain's attention there are currently 30 vacant premises in Ballybane alone at the moment.

Brian was unaware of the vacant post and will make enquiries on the matter.

Support for Ukrainian families We are supporting families looking for childcare and afterschool places. Staff have been facilitating Stay and Play sessions with children and their families in local libraries and some accommodation centres.

Parent & Toddler 2022 P&T grants opened in May with a new strand for an additional session and a buggy walking session which allows for extra funding for groups. Many groups have notified us of Ukrainian families joining and have opted for either an additional session, a buggy walking group or both.

Galway Traveller Movement (GTM) Early Years Project 2022 GTM requested our support with a project to encourage ECCE participation. We met for four sessions in Ballinasloe library with Development Officers from GCC and GTM. Our focus was the introduction to play resources for children aged 0-6 linking it to the preschool and full day care curriculum (Aistear Early Years Curriculum Framework). We also had an opportunity to build on relationships with parents and discuss preschool, full day care and childcare subsidies available for working parents and those who are engaging in further education or training. GTM would now like to mirror this project in Ballybane library and we have invited Music Generation Galway City to collaborate also.

Merlin Woods Community Garden Picnic GCC were invited by Healthy Galway City to collaborate with ARD Gardening Group and ARD Women's Circle and Galway City Partnership to host a *Safe food* Community Food Initiative (CFI) event as part of the Merlin Woods Community Garden Picnic on Sunday 28th August from 2 – 4 pm. This was a free, family-friendly event to promote community togetherness and promote awareness of healthy eating in a relaxed and enjoyable setting. The sun shone and the event was well attended by many from the community and beyond. We had an opportunity to showcase the benefits of play for children with hands on experiences with water, sand, plants and other natural resources.

Refugee Resettlement support A Development officer in GCC is a member of the Galway Refugee Resettlement Interagency group. We have recently been in

contact with support workers, finding childcare spaces in Loughrea, Tuam and Ballinasloe. So far, places have been successfully secured in Tuam and Loughrea.

Information sessions GCC staff attended three *Make the Link Information events* in early September which had huge turn outs. These took place in Tuam, Ballinasloe and Clifden. Information was given out about the finding childcare, National Childcare Scheme, Childminding and childcare courses.

An update from the HSE Drug & Alcohol service.

- There has been an increase in cocaine use which has been reflected in the referrals to the services. Cocaine use increases and decreases with good and bad economic times and this may be one of the reasons for the increasing use of cocaine in the community.
- In relation to referrals there has been a small increase in referrals to the OST clinic.
- An application for extending the Galway Alcohol Service to replicate the Galway Alcohol service in Mayo/Roscommon & Galway county is being submitted.

No Garda update available for this meeting.

Alcohol Forum

• This group is working on increasing the profile of the forum. There was an event in May and also last week with the Galway City Partnership. The theme focussed on elderly people and the impact of alcohol and later life. The event was hosted by Marian Rackard. Orla stated that it is good to link with other services for events increasing the profile of the event offered. Orla stated that we need to consider providing an event on peer influence. Orla stated an event in relation to older people and alcohol should be run

- as part of the 2022 awareness week in November. The event would be a partnership with the linkages that are already present.
- Deirdre Finnerty stated that there is an age alliance and social inclusion event on in Mayo from October 10th to October 14th. In Roscommon there is an action age group with Roscommon County Council. It would be important to work with Comhairle Na Nog in Galway, Mayo and Roscommon. Orla stated that she will link with these organisations in relation to the forum. A question was asked about where older people go to if they have injuries from falls etc after the close of Roscommon hospital. These people are cared for in Castlebar, Ballinasloe and Galway.

Family Support Update

Maria Power gave the update from family support.

- The Family Support service is working with 30 families in Galway, Mayo and Roscommon.
- NVR program including children to parent violence is taking place on the 6^{th of} October in Westside Galway. The Family Support Workers have completed Naloxone train the trainer with staff from Simon, Cope and the Drug and Alcohol Service. Naloxone Training is taking place on September 20th in Ard, 27th September in Castlebar and October 5th in Westside.
- Alcohol Related Brain Injury training is taking place on September 27th.
 The trends shows an increase in Cocaine and Alcohol use affecting family activity in relation to clients seen by the family support service. Parents and partners of the person with addiction are seen by the service. Online resistance training is taking place with Carol Burke and Denise Duggan.
- The WRDATF website has an updated section on family support where suitable clients can avail of appropriate information and guidance.

Community & Voluntary Sector

 A discussion took palce in relation to the LECD (Galway) and final consultation. This is a key role in identifying gaps in the city development board. Deirdre Finnerty stated that Mayo will be accepting submissions in relation to the LECD in the coming weeks and she will notify the WRDATF.

Chairperson Update

There is €200'000 funding available for all Task Forces through the (CSEF) Community Services Enhancement Fund fund. The funding proposal is for under 18's Counsellors and Family Support Worker.

- The moies will pay for 3 under18's Counsellors and 1 Family Support Worker for Roscommon.
- It was explained that this was the best value, target and best fit for the monies. The staff employed will be HSE. If we get the funding it will be part of the CSEF/ HSE budget. This is early prevention.
- The funding for 2022 is pro rata€200'000 for each full year. In 2022 the monies drawn down will be €150'000 to 2023. The idea would be to leverage the existing admin staff. To support these workers

- Training continues online. These include Community Addiction Studies,

- fUrtehr work is ongoing with 3rd level institutions to determine and meet their needs both students/staff).. WRDATF are in the process of meeting ATU staff, and Healthy Campus staff. And Family Support offerings.
