GCCN VISION FOR GALWAY CITY



Galway, a creative and inclusive city that respects and values its people and communities, their wellbeing and quality of life, that will develop a vibrant, sustainable, economy and environment and participative and transparent governance.



Background

Established in 2014 and formally launched in 2015, Galway City Community Network (GCCN) is the Public Participation Network in Galway City. The GCCN work is motivated and guided by values of:

- Sustainability and a concern for preserving and protecting the natural environment;
- Equality and a concern for non-discrimination, valuing and respecting diversity, empowering people, and securing access to social and economic resources;
- Culture and a concern for empowering and fostering the diversity of cultures in the city and enabling people to express their creativity;
- Community and a concern for the physical space, identity, and/or interests shared by a group, where people enjoy wellbeing and harmony, organise collectively, and engage in shared creativity;
- Empowerment and a concern for representation and participation in decision-making and democracy in the city;
- Inclusion and a concern for fostering and ensuring a sense of belonging to and opportunities to engage with one's community and the city.

GCCN Objectives

GCCN pursues to:

- Encourage greater participation in public decision-making which leads to more effective and better targeted policies and programmes at local level and where necessary at a regional and national level;
- Develop alternative methods and models of working which seek to directly involve and empower groups and individuals within the community;
- Support the GCCN elected representatives to achieve the GCCN policy objective;
- Act as a catalyst to influence the sustainable development of Galway City;
- To develop GCCN as a resource for the community, voluntary and environmental sectors and communities in Galway City.

GCCN AIM

The GCCN aim is to co-ordinate and support the representation of the community, voluntary and environmental sectors in Galway City.

GCCN Role

The role of Galway City Community Network is:

- To act as a platform for the groups/organisations engaged in the community, voluntary and environmental sectors in Galway City;
- To develop policy and positions on issues of common concern to the sectors and to communities and to advocate for these policies and positions to be implemented;
- To facilitate the representation of the community, voluntary and environmental sectors on the Local Community Development Committee, the Strategic Policy Committees, the Joint Policing Committee, other local government and local development bodies and any local, regional, national or international body deemed appropriate by the Galway City Community Network;
- To contribute to the development and achievement of a vision for the well-being of this and future generations.

GCCN Purpose

Galway City Community Network:

- Facilitates participation and representation of communities on decision-making bodies in a fair, equitable and transparent manner, through the environmental, social inclusion and voluntary sectors;
- Works to strengthen the capacity of communities and of the environmental, social inclusion, and voluntary groups to contribute positively to the community in which they reside/participate;
- Provides information relevant to the environmental, social inclusion and voluntary sectors and acts as a hub around which information is distributed and received.

GCCN APPROACH

Galway City Community Network has established Linkage Groups:

- To support representatives on the appropriate Strategic Policing Committees (SPC) and other structures;
- To act as a reference point for GCCN representatives in the thematic areas.

In 2020, GCCN has continued to enagage and register members onto the GCCN database in compliance with the GDPR regulations.




On December 31st, 2020 there were 144 member groups and organsiations registered with GCCN.

GCCN Induction


GCCN held two induction meetings in 2020. These workshops provide an introduction to GCCN - the history, GCCN values, structures and processes. A priority for GCCN is to promote social inclusion and equality and this includes embedding these priorities in membership and representation development.

A diversity of communities, including communities experiencing disadvantage, are consistently encouraged to get involved in GCCN and are proactively targeted for these induction workshops.











The GCCN membership is the ultimate decision-making authority and it is open to all groups and organisations active in Galway City that fulfill the criteria outlined in the GCCN Constitution[1].

The GCCN membership meets in Plenary three times a year, and in 2020 the Plenary meetings were held in June, September and December.

The Annual General Meeting coincided with the Plenary meeting held in Sptember 2020.

GCCN Representatives

GCCN elects representatives to a variety of policy and decision-making structures in the city. To this end, GCCN actively targets members from marginalised communities and their representative organisations.

All GCCN representatives are required to attend Linkage Group and/or Thematic Group meetings. To this end, a meeting for representatives is held before every Linkage Group or Thematic Group meeting to ensure that that there is clarity and the knowledge is shared.

While the main GCCN Representatives Elections were held in 2019, two replacement reresentatives were elected on the Local Community Development Committee in September 2020.

In 2020, GCCN organised training on negotiation and representation for current GCCN representatives and potential future GCCN representatives. Ongoing support was offered to all GCCN representatives.



Communications

Communication and information sharing are critical areas of work for GCCN given the need and importance to keep members informed and up to date in various areas. This includes dissemination of information through social and digital media, emails and on the GCCN website.

Public Participation Networks (PPNs) are seen by the government as an important conduit of information and have been tasked with circulating official Covid-19 information since the onset of the alert.

In 2020, alongside the regular newsletter and communications, GCCN circulated COVID-19 related information and updates to all member organisations on behalf of HSE. DRCD and other offical sources.

GCCN also launched a communication campaign aimed at creating a new public database for anyone in Galway City to receive the official COVID-19 related communications. Additionally, a new COVID-19 related webpage was created on the GCCN website displaying the information received from official sources.

Policy submissions

Representing the views of GCCN members on policy development at local, regional and national level is a critical area of work for GCCN. We actively encourage and facilitate engagement in relation to making policy submissions.

GCCN actively participates in written submissions in two ways. We inform members and encourage them to make their own submissions and we request members' input into formulating submissions compiled and submitted by GCCN. All GCCN submissions are underpinned by participatory processes that include workshops, Linkage Group meetings and emails requesting submissions.

Participation & Collaboration

GCCN works closely with a range of organisations and agencies in Galway City, maintaining a focus on coordinating and supporting local participation in decision making structures. A series of events and meetings were co-hosted/co-organised/participated throughout 2020 and these include:





#EqualityVotesGalway

In 2020, #EqualityVotesGalway (#EVG), the consortium of local organisations and GCCN members that work collaboratively on equality issues, developed a Manifesto for the National Election.

In January 2020 the consortium organised a live streamed event with Galway Politics Live inviting all Galway candidates to sign the manifesto and participate in the discussion on how to put equality at the heart of government.

Following the national elections and in line with the previous work done during the local elections in 2019, the role of #EVG was to hold the elected councillors to account on an equality agenda. The consortium attended Galway City Council meetings in an observational capacity and supported members to access training on equality issues.

The organisations involved in #EVG include Galway City Community Network, Galway City Partnership, Galway Traveller Movement, AMACH LGBT Galway, Cope Galway, Threshold Galway, the Bridge Project, the Disability Federation of Ireland, Access for All and the Galway Anti Racism Network.



Flowers for Magdalenes

GCCN continues to work collaboratively with a small number of organisations to organise the Magdalene Women and Children Commemoration (Flowers for Magdalenes) on an annual basis. The 2019 commemoration was held on Sunday March 31st.

National Social Enterprise Strategy

In May 2019 GCCN held a workshop with GCCN members to develop a response to the National Social Enterprise Strategy. Following this GCCN completed a submission.

Local Community Development Committee (LCDC)

In 2019, GCCN supported the active participation of its representatives on the Local Community Development Committee and continues to do so.

In addition, GCCN is active in the Social Inclusion Subgroup of the LCDC and is represented on the LECP Advisory Group.

Public Sector Duty - Equality & Human Rights Framework

The Equality and Human Rights Statement, launched in 2018, acts as a tool to support implementation of the Public Sector Duty to have regard to the need to Eliminate Discrimination, Promote Equality of Opportunity and Protect Human Rights.

In 2019 GCCN has worked with the Galway City Local Community Development Committee, Galway City Partnership and others on a on an initiative to facilitate the production of the Equality and Human Rights Statement and the production of a toolkit to support agencies to implement their obligations under the Public Sector Duty. GCCN took a lead on a collaborative effort to establish a Civil Society Panel, the first of its kind in the country, to represent the nine grounds of the equality legislation and the ground of socio-economic status.





Galway Healthy City

GCCN worked closely and collaboratively with Galway City Council, Galway City Partnership and the HSE as an active member of the Healthy Galway Steering Group in the development and implementation of the Healthy Galway City Strategy, including supporting the development of the application to the third round of Healthy Ireland funds and the implementation of the subsequent action plan. In June 2019 the Healthy Galway Strategic Plan was launched by Minister Catherine Byrne in Westside Library. Ann Irwin, the GCCN Co-Ordinator spoke on behalf of the Healthy Galway Steering Committee on this occasion.




The GCCN Co-ordinator is the G2020 'Legacy Champion' for Sustainability and attended two meetings of the Sustainability 'Champions' in March 2019. GCCN continued to support Galway 2020 throughout the year.

Galway Environmental Network

In 2019 GCCN continued to support Galway Environmental Network through capacity building, organisational and overall support. GCCN remains an active member of GEN and the GEN Committee.

Galway Community Excellence Network (EVOLVE)

GCCN is a member of Galway Community Excellence Network (EVOLVE) Steering Group, whose members include Galway Volunteer Centre, Cope Galway, Saint Vincent de Paul and Galway Community Circus. This collaborative network secured limited funding to identify and source the training needs in the community and voluntary sector in Galway City. A training was held in May 2019.










Community Enhancement Programme

GCCN co-facilitated two sessions on the Community Enhancement Programme with Galway City Council and Galway City Partnership on May 8th 2019 in Ballinfoile Castlegar Neighbourhood Centre and on May 9th 2019 in Westside Resource Centre. This was targeted at member organisations, amongst others, of GCCN.

LC DC

Galway City Local Economic and Community Plan Review

GCCN worked closely with the LCDC and Galway City Council to facilitate the review of the Local Economic and Community Plan (LECP) 2015-2021 and the development of a new LECP Implementation Plan 2020-2021. Galway City Council organized an initial needs assessment workshop followed by two thematic workshops. In addition to City Council's workshops, GCCN held a preparatory workshop aimed at preparing GCCN participants and requested that Galway City Council organised a third evening thematic workshop to facilitate those who could not attend the workshops held during working hours. This workshop was inclusive of the initial needs' assessments and the two thematic workshops.





National Participation


